Please, consider the needs of this breed. They do need real fencing and adequate exercise. They are large and powerful sighthounds. If it runs, they will chase it and if they catch it, they will more than likely kill it. Also be mindful of the typical and unexpected costs and expenses that do come with owning a giant hound. Many, unfortunately, are not prepared for the financial costs. Please do take into consideration that their size does necessitate more nutrition expense, time spent grooming and potentially large medical bills.

- 1. All puppies will be Liver Shunt tested prior to leaving for their new homes no earlier than 12 weeks.
- 2. All puppies will have socialization using Puppy Culture and Avidog Puppy Resources.
- 3. All puppies will have age appropriate vaccinations. I follow Dr. Jean Dodd's protocol.
- 4. All puppies will have been on a Deworming schedule since 2 weeks of age.
- 5. All puppies will be registered online by myself and the Limited Registration paperwork will be emailed to the new owner from AKC.
- 6. All puppies will be microchipped and enrolled with AKC Reunite when I register the puppies. I will remain as 2nd Contact on the Contact Form as the Breeder of the puppy.
- 7. All puppies will be sent home with a large bag of their current food.
- 8. You will receive a 3 Ring Binder with all paperwork, including a copy of the Contract, vaccine schedule, deworming schedule, Vet Health Certificate, a lot of health information including Pneumonia Protocol, Bloat, Heart, proper exercise for a puppy, feeding schedule, grooming methods and tools, etc. Copies of the Parent's Health tests will be included and pedigree.
- 9. All puppies will be sent home with any supplements that they are currently on, such a Vitamin C, Cranberry, Omega 3.
